### Medical Council Malta Statutory Examination for Medical Practitioners held on Wednesday 4<sup>th</sup> April 2012

17<sup>th</sup> April 2012

#### To the President Medical Council

During Council Meeting No 03/2010, dated Wednesday 1<sup>st</sup> February 2012, the Medical Council re-appointed Mr Charles Messina to act as the Examination Coordinator. Mr Messina held various meetings with the Examiners (table 1) in order set up the examinations and the schedules.

In the meantime, the Registrar informed all the candidates who had submitted their application since the Medical Council Malta Statutory Examination (MCMSE) held on 19<sup>th</sup> September 2011, to confirm that intention by Friday 27<sup>th</sup> January 2012. Six (6) applicants replied by the date stipulated, however, only one (1) candidate was able to sit for the examination (table 2). As per LN330/2006 the applicant paid the amount of € 1170.

The Examination was held on Wednesday 4<sup>th</sup> April 2012, at the Medical School, Mater Dei Hospital.

The examination was conducted in the form of an interview (Viva Voce) in English. The candidate was examined in the following subjects with two examiners during each session. Approximately ten minutes were allotted to each examiner. The whole examination took about eighty minutes.

The Groupings were as follows:

Medicine/Public Health  
Family Medicine/Obstetrics and Gynaecology  
Paediatrics/ Psychiatry  
Surgery/Pathology

All subjects were failing, that is, one must obtain a pass-mark of fifty (50) in all the subjects.
